San Jose Golf Scholarship Application Instructions

Statement of Intent

The San Jose Golf Scholarship Program will ensure that qualifying San José residents will have access to participation to City of San Jose Golf Courses. **All requests are subject to available funding.**

Eligibility Criteria

1. The San Jose Golf Scholarship Program will operate in two (2) steps. Step 1 is for the customer to submit the application and eligible documents in person at the participating Golf Courses. Step 2 is for the customer to register for the class if scholarship is approved.
2. San Jose Golf Scholarship Applications will be available at San Jose Municipal Golf Course, Los Lagos Golf Course and Rancho Del Pueblo Golf Course. Applications may also be downloaded online. Applications for the San Jose Golf Scholarship Program and proof of eligibility will be accepted in person only at each available location for review. If qualified, scholarships will be available only during the program application year indicated on the San Jose Golf Scholarship Application. Funding is subject to availability.
3. Scholarship recipient must be a San José resident. **Proof of residency includes utility bills dated within 60 days of the application that have the name and address of the participant, parent or legal guardian and must be submitted with application.**
4. **Eligibility documentation is required and copies must be submitted with application.**
