This position is well suited for an experienced General Manager looking to take the next step in their career with aspirations for continued growth within the company.

This Multi Course General Manager position oversees daily operations at Los Lagos Golf Course with oversight and support of San Jose Municipal Golf Course and Rancho Del Pueblo Golf Course. In addition to daily operations this position will be responsible for project management of several large capital projects scheduled at all three courses over the next several years.

Los Lagos Golf Course:

Opening in 2002, Los Lagos Golf Course is the cornerstone of San Jose's recreational offerings. The par-68 course is conveniently located in the heart of San Jose. The 5,393-yard course includes a competitive mix of nine par-three, four par-four, and five par-five holes suitable for all levels. Additionally, there is a two-deck lighted driving range with 45 stalls. Los Lagos combines environmental sustainability and community involvement with a recreational facility accessible by everyone.

This position has the direct responsibility for managing Los Lagos and will supervise golf operations including marketing and promotion, golf course maintenance, food & beverage, community programming and will manage interdepartmental coordination. This position is responsible for contract compliance and for ensuring the clean, attractive, and safe condition of public and non-public areas of the property at all times. Furthermore, the General Manager will execute marketing strategies and organize community outreach efforts. This position will also oversee and support San Jose Municipal Golf Course and Rancho Del Pueblo Golf Course. This position will work directly with the General

Managers and onsite Management Teams to provide leadership and support. The General Manager will also manage and lead capital projects at all three golf courses. This position assists the Senior Operations Manager, the Chief Operations Officer and the Chief Executive Officer in the successful growth and operations of the company.

Job functions include: Development and management of golf course budget; training and supervision of staff; tee sheet and POS management. Position is directly responsible for management of all departmental functions including maintenance, golf operations and food & beverage. The General Manager will coordinate the formation of player development programs. Position will ensure desired level of customer service is always met.

Successful candidate should have 5+ years' experience as a General Manager, Director of Golf, or equivalent at a high volume, high quality public facility.
